Young Handlers may enter ANY dog regardless of awards and ownership.

Novice. Dogs which have NOT won a Novice Test,
or gained a 1st, 2nd or 3rd in an Open Test or ANY Field Trial award, incl. COM.

Puppy. Confined to dogs NOT older than 18 months on the day of Test.

Open. For dogs with ANY Test OR Trial Award but excluding Puppy Test Awards.

Entry fee for all Tests - £10 per dog.

Young Handlers under 17 years of age – FREE entry for ALL Tests.
