Qualification Definitions for Spaniels as per J7i(2)

OPEN: Preference in the draw will be given to dogs which have gained awards 1st, 2nd or 3rd in an Open Stake or 1st in All Aged or Novice Stakes.

NOVICE: Dogs NOT to have gained a 1st, 2nd or 3rd in an Open Stake or 1st in All Aged or Novice Stakes

YOU MUST SEND AN SAE OR eMAIL ADDRESS FOR RESULT OF DRAW

Directions to trials and meet times will be sent out with the result of the draw by post or email.

Trophy and prize details will be printed on the card on the day of the trial.

All our trials are held under Kennel Club Ltd Rules and Field Trial Regulations 'J'. Should circumstances so dictate, the Club, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them will be reported to the KC at the earliest opportunity. No modifications will be made to this schedule except by permission of the KC, followed by an advertisement in the appropriate journals if time permits before the closing of entries. We reserve the right to refuse any entry, except that this shall not apply in terms of the preference in the draw. Substitutions of dogs will be allowed subject to qualifications as above.
